3.3 Contact forms

We may collect, transfer and store your personal data within any member of our group, which means subsidiaries, our ultimate holding company and its subsidiaries, as defined in section 1159 of the Companies Act 2006, including those outside the European Economic Area.

Your Rights

Your rights

Data protection law grants you certain rights in relation to the use of your personal information. These rights include amongst other things:
